The ONC recommends that Real World Testing verifies that deployed Certified Health IT continues to perform as intended by observing interoperability and data exchange. This test plan focuses on documenting the number of times certified capability is successfully used in the real world. The approach involves end-to-end testing with real end-users, both clinical and non-clinical. This method goes beyond the developer's understanding of usability and includes user feedback and reporting of any issues. Success is defined by meeting criteria and documenting at least one specific metric per measure through Real World Testing. This approach requires a commitment to real end-users in the production environment.
